### **Terms & Conditions**

1. The **Diamond Deals – Snacks & Meals** promotion will be held at SKYCITY Darwin commencing from Monday 15<sup>th</sup> February 2016 and continuing until further notice.
2. The following are ineligible to enter this promotion:
  - i. SKYCITY staff, of any capacity
  - ii. Spouses and/or de-facto spouses of SKYCITY staff
  - iii. Persons under the age of 18 years
  - iv. Any person who at the time of the promotion/draw is excluded under the relevant provisions of the Northern Territory Gaming Legislation
  - v. Players of IB-Domestic or IB-International Business levels
3. This promotional offer is exclusive to Premier Rewards **Diamond** members. Only current Diamond members of SKYCITY Darwin's Loyalty Program are eligible to participate.
4. There are two types of voucher on offer; a snack voucher and a meal deal voucher.
5. These offers are available during opening hours of the relevant bars and restaurant, 7 days a week.
6. **Snack Offer**
  - i. Upon earning 50 Premier points on the day, a diamond member can redeem a snack voucher from the Premier Rewards desk
  - ii. A member is allowed to redeem one snack voucher only per day
  - iii. The voucher expires 7 days after issuance
  - iv. A member must order their snack from the Diamond bar, Sandbar or the Vue
  - v. Before ordering, the member must present their snack voucher and their Diamond membership card to the food and beverage attendant
  - vi. The choice of snacks will vary from time to time but will most often include a choice of:
    - a. Chicken | 2 x wing dings
    - b. Selection box | 1 x party pie | 1 x sausage roll | 1 x dim sim
    - c. Vegetarian | 1 x large spring roll | 1 x samosa
    - d. Wedges | 1 x large tray
    - e. Sandwich | choose from selection
  - vii. SKYCITY reserves the right to alter the range of snacks without notice at any time
  - viii. Should an item(s) not be available, the member is required to choose an alternative snack or choose to use their voucher at another time
7. **Meal Deal Offer**
  - i. Upon earning 200 Premier points on the day, a Diamond member can redeem a meal deal voucher from the Premier Rewards desk
  - ii. A member is allowed to redeem one meal deal voucher only per day
  - iii. The voucher expires 7 days after issuance
  - iv. A member must order their meal deal from the Vue restaurant
  - v. Before ordering, the member must present their meal deal voucher and their Diamond membership card to the food and beverage attendant
  - vi. The meal will be from the current 'Cheap as Chips' meal offerings plus a drink.
  - vii. For their drink, the member has a choice of the following:
    - a. A midi of tap beer (excluding Asahi)
    - b. A 150ml glass of house red wine, white wine or chardonnay pinot noir
    - c. A soft drink
    - d. A coffee or tea
  - viii. SKYCITY reserves the right to alter the meal and range of drinks available without notice at any time

- ix. Should a specific drink not be available, the member will be offered an alternative.
  - x. Should the 'Cheap as Chips' meal have sold out, the member will be required to use their voucher at another time, though we will endeavour to maintain supply.
8. A Diamond member is permitted to redeem one snack voucher plus one meal deal voucher every day that this promotion is running, upon earning the required Premier points.
9. The membership number on the voucher must correspond with the membership number on the persons Diamond card in order to redeem the offer.
10. Points Earning - Diamond members earn points when using their membership card, at the following ratios:

	Diamond
Gaming Machines	\$4 Spend = 1 Point
Table Games	Based on average bet, game & time played

11. Upon the appropriate number of points being reached and the member visiting the Premier Rewards desk, the host will redeem the coupon on a members Patron Management account and issue the requested voucher. The Premier points will remain on the members account.
